## EXECUTIVE DIRECTOR LETTER TO THE ASSOCIATION 2015-2016 ANNUAL REPORT

Dear BAGBR Family,

This 2015-2106 year has been another productive and fruitful season of work in kingdom advancement in BAGBR. As you think of the work of the association, it should be with the understanding that we are an extension of every local church and a strategic partner with every church as well as LBC and our national SBC entities. From those particular BAGBR ministries that are listed and recognized you can see the breadth of the associational work from church planting, to camp ministry, to prison ministry, to world missions.

There are three notable highlights this associational year that mark an expansion and a greater intensive intentionality in taking the Gospel to our world, locally and internationally.

We are thrilled to have a full time BCM director at Southern University. Jason Thomas, and his wife Gaynel, began work in Baton Rouge in late May 2016. Jason brings much experience from his time of doing student work in New Orleans and is returning to his home to work with students. He spent his first week on the job with us in our Inner City Camp for middle schoolers and has not slowed down yet. I urge you to have Jason in your churches, introduce him to your congregations, he will bless your people and encourage them.

We launched two new areas of International ministry this year. In January 2016, I had the privilege to lead a small team to Malaysia and work with IMB personnel there. Our strategic assignment was street evangelism and engagement with the local population which proved to be very fruitful and encouraging. We were greatly encouraged by the quality of our IMB teams there and have planned a return trip in 2018. In September 2016, I led a slightly larger team of ministers and laity to Belarus for 12 days of preaching, teaching, evangelism, and conference work in this former Soviet nation. It was a tremendous experience. We were stirred by the hunger for the gospel and gospel work that the people had. We were greatly blessed by the sincerity and commitment of our Belarusian Baptist family...God is doing a great work there and plans have already been put in place for a more intensive work in the fall of 2017.

But that which has dominated our efforts, energies and resources over the last two months has been the flood of 2016. When the rain began to pour and pour on August 11-12 we at that time could not have imagined the magnitude of devastation that would come with it. Water rose quickly and so high that areas, no one ever imagined would be flooded, were inundated. Of our 105 churches and missions in BAGBR, 24 of them were flooded, most of them had water in all their buildings. A total of 58 buildings were flooded. Over 35 staff members from our different churches were flooded as well, and many congregations experienced flood damage of up to 80% among their congregations. And what were our churches doing? Being the church!!! I have never been so grateful to serve with our BAGBR churches as I was in these past days. Almost all of our churches that were not flooded came to the relief of churches and communities in unprecedented fashion. Even as the water began to rise so did our churches rise to the occasion. This was an unprecedented challenge, they're now calling it a 1000-year flood, and yet it was and is an incredible opportunity to be the church and to love our community and point them to Jesus Christ as we minister to them in His name. Your churches were at the tip of the spear from day one and are still working diligently. Those first 3 weeks were incredibly intense and most of us, pastors and laity, were working 24/7 to mud out, dig out, haul out, and clean out the affected buildings and houses. Disaster Relief (DR, go Yellow hats!) from LBC and SBC (NAMB) joined us quickly and provided the lift and partnership that we needed. Churches and individual believers from all over the US called, gave, came, and they are still calling, still giving, and still coming. As I told someone, I am so thankful for my salvation but these days it has made me so grateful to be Southern Baptist.

BAGBR has been very intentional in supporting and connecting our local churches with DR (LBC and SBC) as well as other associations and churches from our region that have come in to help. Also, our strategic focus has been to work with the 24 churches that were flooded to get them back up as soon as possible and put them back on their feet. We have teamed with them not just to return them to the way they were but to return them renewed and refocused to a new level of effective ministry. You can see below our IMRC plan and subsequent letters sent out to churches as we seek to move forward to advance the Gospel. As I look back on these recent days of great ministry and Gospel work, I do believe that there is more openness and interest in the things of God and we are going to realize an amazing harvest from this "sowing" season in the weeks, months, and years to come.

#### Letter from the Director of Mission to the BAGBR Churches that Flooded

Hey Flooded Brothers,

[This note is only to those pastors who have had water in their buildings during the flood.]

These past weeks we have seen so many challenges in getting your church buildings dry, clean, and sprayed, and at the same time having your own house and a sizable percentage of your congregation's houses to "mud out". Let me say that I have been so blessed by your vision, work, and joy; you have blessed my life and all who have observed you have been blessed as well.

We are nearing the completion in most of our church buildings of the stage 1-Deconstruction, and about to begin stage 2-Construction. With so much "Help" coming our way, we may be so quick to rebuild that we have not taken the time to rethink what God would have us do or not do in the next stage. May I ask each of you to consider taking a week or more of prayer and study about what the next steps may be. It is not just about rebuilding but refocusing and refining the ministries that God has given us. We may need to consider a redirection and even renovation so that we are building based on faith and need. Would you be willing to take some time to walk around the buildings as did Nehemiah and listen to God's prompting, seek counsel from many ministry sensitive leaders, and spend time in his Word for clarity and confirmation. If possible, would you be available to talk through the process with me. Your "processing" may help us see more clearly where this New journey of ministry may be leading us.

In Christ, Tommy Middleton **Disaster Relief Update -** Thank you for your great generosity and kindness to give and to serve in the Disaster Relief work here in the Greater Baton Rouge area. There are many needs but no greater need than prayer. Please pray for our tireless servants who continue to labor, seeking to be the hands and feet of Jesus in the flooded areas.

To grasp the magnitude of the flooding, the "affected zone" spans more than 100 miles along the Interstate Highway 10/12 corridor. Baton Rouge and Denham Springs are at the center of the disaster with the most flooded homes. Here are some facts about our current area:

- Estimates vary but at least 75K homes were flooded
- Over 150K families displaced
- More than 70 churches in this affected area had moderate to severe water damage
- Of the 105 churches and missions in the Baptist Association of Greater Baton Rouge (BAGBR) 24 churches were flooded
- Over 30 BAGBR church staff members were among the flooded
- Some of our congregations had as high as 80% of their membership flooded
- As of the last week of August over 100K had applied for FEMA assistance

In spite of the tremendous challenges, you would be so encouraged with the response of the churches here working as one church—they were and are at the "tip of the spear" in water rescuing, sheltering, feeding, cooking, cleaning, praying, supplying, and mudding out. The monies that you so generously donated will go directly to the churches and individuals that are in the greatest need. To date we have received \$89,513.39. Thank you

#### Letter from the Director of Mission to the BAGBR Churches that Did Not Flood

To Churches that were not flooded but who have experienced unscheduled flood ministry, Although most of our churches were NOT flooded with the rising water, almost all of our churches have been addressing the flood by doing incredible, intentional, effective ministry to the affected areas and churches. THANK YOU! All of us have had to adjust our schedules, fall plans and events especially for late August and the month of September to be on task and mission with these most pressing needs. These adjustments may last throughout the fall and beyond. As I have been walking through this, it has been a reminder and testimony of what the church looks like when she is on mission—everyone suddenly mobilized and motivated to make a difference, to help, to find a work to do and do it selflessly and tirelessly. I know we all wished we could experience this type of consuming gospel passion 24/7 in our local fellowships but to maintain such a high level of intentionality is difficult if not impossible to sustain. However, there are some strategic take-aways, readjustments that we all should make and reflect in on our programming and planning so that our ministries become more Gospel intentional, people focused, and body life cooperating. The Apostle Paul made many statements about how we should respond to trials, troubles, and changes in life...two come to mind.

- 1 Thessalonians 5: 18—in everything give thanks.
- Ephesians 5: 20—Giving thanks **for** all things.

Giving thanks means my willingness to look at my world and events from God's perspective, from His Word and allowing Him to change me, change my world to bring me more into compliance and surrendered to His will for my life. It would do us all well, in a few weeks to have a day of reflection with our staffs, and possibly church body and ask:

- What did we learn in the flood?
- What did we learn immediately after the flood?
- What did we learn from the flood?
- How should our ministries change as a result of what God allowed us to go through?
- How should my own walk and ministry change or adjust as a result of what God allowed us to go through?
- How can we follow up and follow through with the numerous lives that we have touched and been touched by in these days?

May these days be days of Grace and Glory.

#### **Cultural and Political Awareness**

The upcoming presidential election has once again reminded us of the importance of our political process. In 2012, twenty-five million evangelicals did not vote. We have now seen the results of that neglect. A vacancy still exists on the U.S. Supreme Court, our economy is dangerously close to a depression, our military is the smallest that it has been since the start of World War II, and our bathrooms are no longer safe for our children to go into. While you may not be satisfied with either candidate, each has a significantly different agenda. It is imperative that Christians vote based on biblical principles and not party affiliations. To that end, voter guides will be available for every church. Please distribute them to your members before the November election.

At the state level the atmosphere is different with our new governor. Evangelicals do not have the same status that they enjoyed under Governor Jindal. We have suffered some setbacks in terms of religious freedom, special protected status for the LGBT community and other issues that impact or beliefs. Please make yourself aware of the issues that are upcoming in the next legislative session. Make sure that you know how to contact your Senator and Representative so that your voice may be heard.

#### **Evangelism and Outreach**

The flood of 2016 devastated this area. While the damage was immense the opportunity for a Gospel witness has never been greater. Again, Southern Baptist Disaster Relief made a tremendous impact on our community by their sacrificial giving of time and talents to anyone who had need. That has opened the door for evangelism like never before. I pray that our churches are taking every opportunity to be intentional in sharing Jesus as they share the resources for recovery. We have heard some pretty amazing accounts of professions of faith in the midst of the storm.

Evangelism training is continuing on the LSU campus. Eleven students are currently enrolled in EE training that will continue through November. Please keep this ministry in your prayers. It is awesome to see what God is doing in the lives of these students who have made the commitment to share the Gospel. About a fourth of our churches are involved in Compassion Ministry through (before the flood): Recovery Ministry, Prison Ministry, ESL (English as a Second Language), Clothes Closets, Food Pantry, Disaster Relief, Divorce Care, "Hope Mobile" Kids Community Ministry, Refugee Ministry, Human Trafficking and Homeless Ministry. There are many others that I have not listed and I would love to learn about.

On January 8-9, Istrouma Baptist hosted an ESL training for churches in our area led by Shannon Brown. It was a wonderful time of discovering and learning how to meet needs and share the Gospel through teaching English.

On March 24, Istrouma Baptist hosted a Mud-Out Disaster Relief Training lead by Charles Watson as churches began to respond to the floods in eastern LA. (...many more were offered during the month of August and September)

On April 16, Parkview Baptist hosted our meeting with special guest Kujanga Jackson. We spent the time covering two areas of ministry: multi-housing ministry and after school ministry. It was good and we hope to offer more opportunities in the future.

The growth area in Compassion Ministry this year, for obvious reasons, is the number of churches who are now involved in Disaster Relief. This was essential for our community and ministry but the hope would be that it is a foundation laid of necessity with a potential for greater ministry of the Gospel in the future.

THANK YOU for your prayers and support this past year. As many of you know, this has been a difficult summer. Thank you to our staff and volunteers who ministered so effectively – being the "hands" and "feet" of Jesus. Romans 8:28 states that "all things work together for good to them that love God and called according to His purpose." We have stood on this promise this summer. 141 Professions of Faith were recorded at our camps; 105 recommitments and 31 surrendering to Christian service.

The Mission Statement of the Baptist Collegiate Ministry at Louisiana State University is "Knowing Christ and Making Him Known." The BCM is a religious organization serving the students on the LSU campus. The goals of the BCM are to 1. Reach students for Christ. 2. Connect students with a local church. 3. Strengthen students in their faith. 4. Mobilize students for missions and leadership.

- 1. <u>Leadership Teams</u> A total of over fifty students are serving on the BCM Leadership Team during the 2016-2017 school year. These students plan, coordinate and implement the various BCM ministries.
- 2. <u>Attendance</u> Over six hundred different LSU students have attended one or more of the BCM ministries during the 2016-2017 school year.
- 3. <u>Monday Lunch</u> Monday Lunch is held from 11:40 a.m. to 12:20 p.m. each Monday. A local church provides a meal, which is followed by a devotion by a student or local staff member. The average weekly attendance for the school year is one hundred and seventy-five.
- 4. <u>TNT</u> TNT (Thursday Night Together) is held at 7:00 p.m. each Thursday night. TNT is a time of praise and worship followed by a speaker. Our average weekly attendance for this school year is one hundred and sixty.
- 5. <u>Bible Study Groups</u> The BCM is sponsoring over fifteen Bible study groups each week involving over one hundred students.
- 6. **Evangelism** Five students have confessed Christ as Savior during this school year.
- 7. <u>Mission Arlington</u> In December of 2015, over eighty students participated in a mission trip to Mission Arlington in Arlington, Texas. The BCM is going back in December of 2016.
- 8. <u>Ski Trip Bible Conference</u> Thirty-seven BCM students participated in the annual BCM Ski Trip to Winter Park, Colorado in January of 2016. The BCM will ski in Crested Butte in January of 2017.
- 9. <u>Hawaii Mission Trip</u> Eight students and staff from the BCM and First Baptist Church of Baton Rouge participated in a mission trip to Hawaii during the LSU Spring Break. FBC and the BCM will be going back in 2017.
- 10. <u>Mexico Mission Trip</u> Thirty BCM students and staff served in Piedras Negras and Morales, Mexico during the LSU Spring Break. The BCM will go back to these and other cities in 2017.
- 11. <u>International Ministry</u> There are over 1,800 International students attending LSU from over 120 different countries. The LSU BCM sponsors a weekly International Student Dinner on Monday at 5:30 p.m. Over three hundred different International students attended during the 2015-16 school year.
- 12. <u>Freshmen Leadership Team</u> Over thirty freshmen are serving on the BCM Freshmen Leadership Team. This is a leadership/discipleship group for freshmen.
- 13. **The SEEK Gospel Worship** is held each Monday night at 7:30 p.m. Over thirty different students have attended one or more of the SEEK Gospel Worship Services during the 2016-2017 school year.
- 14. <u>GEN SEND Team</u> Ten students served on a North American Mission Board Gen Send Team in Toronto, Canada in the summer of 2016. They were involved in church planting.
- 15. **Spain Mission Trip** Sixteen students and staff traveled to Spain on a mission trip during the summer of 2016. They were involved in evangelism and kids' ministry.
- 16. <u>Church Camp Staffers/Church Interns</u> Thirty-five BCM students served as interns at their church or at a church camp, such as Pine Cove, Sky Ranch, Centrifuge, Kanakuk, or Camp Ozark in the summer of 2016.

## CHURCH PLANTING 2015-2016 ANNUAL REPORT Kirk Jones, Church Plant Team Leader

BAGBR continues to be involved with many different church plants. Many of our new plants had a great year this last year. We have seen 10 people baptized in our church plants. There have been 90 professions of faith. These new works average 363 in worship. We are proud of the hard work being put in by these church planters and their core groups as they work to start new works in our area.

Our church planting among language groups is growing more active. Louisiana Kachin Church had a strong year this year and continues to move forward. Istrouma Española started this year and had a strong start plus Jefferson is beginning a Spanish-speaking church this year also. Several churches in the Ascension Parish area are also in discussion of how to work together to see a new Spanish-speaking church begin in this parish. We hope to continue to see these types of work receive priority from our local churches and look forward to cooperating together to make these a reality.

We hope your church will take a serious look at your own surrounding area and your people and ask the Lord how he might desire you to be a part of a new work. What type of church plant might be birthed from your congregation? How *can* your church be active in a new work? (*Not why can your church NOT be involved?*) Asking the right questions goes a long way in finding the right answers. We hope you will pray about how you might be able to participate in a new work this year.

If your church can give \$50 per month you are making a great investment in the Kingdom of God. If your church has little money to give but has some people who could be helpful in a new work, send them out. If your church can walk alongside a new church planter and encourage his family, encourage. If your church has the capacity to pray for specific needs of a church plant, adopt one and be faithful to encourage them through prayer.

We hope you will join us in our efforts to plant God-glorifying and Gospel-proclaiming churches in 2017.

#### INNER CITY YOUTH CAMP ~ CAMP BEYOND

#### 2015-2016 ANNUAL REPORT Valerie Butler

Camp Beyond-Middle School is an inner city ministry that reaches out to boys and girls between the ages of 11- to 13 with the Gospel of Jesus Christ through the experience of camping. The mission of *Camp Beyond* is to help the youth come to know Jesus Christ as their personal Savior, to develop the spiritual discipline of prayer, to daily read the Word of God and to apply His word in their daily living. The youth are taken out of the city to the *Judson Baptist Retreat Center* where they connect with God through the natural surroundings. During the week, campers have the opportunity to make connections and establish lasting relationships with other youth from other inner city churches through the various activities offered, *Bible Studies*, *ConneXion Groups*, *Worship Periods* and *Recreation Games*. The dates for this years' camp were May 23-26 and the theme was *Crossroads: What to Do When You Don't Know What to Do.* Participating in Camp Beyond this year were 8 churches, 8 pastors, 20 counselors and 50 campers. During the camping experience, 15 campers rededicated their lives to Christ. New to Camp Beyond was The Temple of New Life Baptist Church located in Maringouin, Louisiana under the leadership of Pastor Edward Scott and Plymouth Rock Baptist Church in Plaquemine, Louisiana under the leadership of Pastor Lee T. Wesley. We thank God that they were a part of our camping experience.

In addition to *Camp Beyond-Middle* there was also *Camp Beyond-Senior*. *Camp Beyond-Senior* is a high octane impacted weekend that ministers to those in high school beginning at age 14 to the first semester college student. The mission of *Camp Beyond-Senior* is the same as that for the middle school but on a more advanced level. During the weekend campers are divided into various groups with a lead facilitator that addresses issues and topics such as their personal walk and devotional time with Jesus, their purpose and calling by God and how they deal with peer pressure. They are able to connect with fellow campers through late night activities, team competition and evening worship rally. The dates for *Camp Beyond-Senior* were June 24-26 and the theme was *The Born Identity (My Identity in Christ)*. There were a total of 20 campers, 5 churches, 6 pastors and 6 counselors. During the weekend five rededications were made while many others came to the alter for prayer.

The vision of *Camp Beyond* is to reach children and youth for the Kingdom of God, so in keeping with what God has commanded in His word, *Camp Beyond* will now expand to elementary school, grades 1 through 6. Please join us in prayer as we ask God's continuous guidance in reaching the children and youth with the word of God.

We want to thank the pastors and churches that supported the camps with prayer and financial support. Once again, we thank Dr. Tommy Middleton for his prayers, leadership and his participation every day at both of the camps. To God be the Glory.

# NEW ORLEANS BAPTIST THEOLOGICAL SEMINARY THE JOAN HORNER CENTER, NOBTS ~ LSP, ANGOLA, LA 2015-2016 ANNUAL REPORT Rick Sharkey, Director LSP NOBTS

The Bible College at Angola has undergone some changes in the past year. After 21 years of service to the Bible College, Dr. John Robson retired as the Director. The new Director, Dr. Rick Sharkey, is the Sr. Chaplain and was mentored by Dr. Robson for over a year before assuming the leadership role. Dr. Robson's influence for the Kingdom is a well-documented blessing to the men at Angola. He continues to teach as a professor at the college.

Another new element at the college is the addition of a second cycle of classes. Dr. Sharkey recruited potential Bible College students from across the state's other male correctional facilities. Last August, 29 new students were transferred to Angola to begin classes in the Fall. Currently, the Bible College has 149 full-time students in two different cycles of classes. On an average day, the 11,000 sq. ft. facility is a very busy place. This addition required additional faculty and additional computers for the lab. God is continuing to bless the ministry of equipping men for Kingdom ministry through the local church congregations in Angola and in inmate churches throughout the state.

The Bible College has 260 graduates to date. With the addition of the second class cycle, graduation will be celebrated every 2 years instead of the former 4-year cycle. These graduates are being used by the Lord to supply Angola's 28 inmate churches with equipped staff. In addition, the Chaplain's department employs graduates for ministry in every living area, including Death Row. Recently, one of the graduates was sent as a missionary to Grant Parish Jail; the first missionary sent to a jail. Inmate ministers deliver death notices, conduct funerals, perform baptisms and conduct pastoral counseling, as well as teach and preach in the churches. God is at work in Angola!

# PRISON MINISTRY REPORT 2015-2016 ANNUAL REPORT Marvin Collins, Director Prison Ministry Task Force

2016 has been a good year in prison ministry.

- We have maintained a discipleship ministry in State Police Barracks, and in both East Baton Rouge and Iberville parish prisons.
- We have men and women from our churches who are able to enter Angola, LCIW and Elayn Hunt. They minister by leading Sunday School, a bible study class, or discipleship study. (Note: Due to the flooding the classes at LCIW have been suspended. We hope to begin again.)
- We have also done the ground work in training new Prison Ministry Task Forces in New Orleans Parish Prison, Livingston Parish Detention Center.
- We have also mentored some pastors at Angola, but we are still in need of other pastors and staff members who will mentor these men in their developmental stage of ministry.
- We hope to begin discipleship studies in Pointe Coupee and West Baton Rouge parishes.

Many others work in the other areas of prison ministry.

- Some labor in the ministry of preparing Baton Rouge to produce fewer criminals. This involves working in summer camps for at-risk youth, lobbying for more just laws, and ministering to the children of presently incarcerated parents.
- We have people working in the prisons to disciple inmates so that when they get out, they are abler to integrate into society. These inmates are facing a richer life when they integrate into new relationships.
- Each October, BAGBR and the LBC sponsor a weekend revival and ladies' day for the women offenders at LCIW in St. Gabriel. Due to the flooding, the women were move to other facilities throughout the state and we were not able to have the revival. We were still able to give each offender a gift box of items (soap, socks, shampoo etc.) provided by Louisiana Baptists from around the state. We are looking forward to having the revival in October 2017.

Our goal is to enhance and support the work of all LBC Teams so they accomplish the missions and ministry goals of the Convention.

In addition to coordinating the Annual Church Profile (ACP) process for the state, Shana Johnson serves as Information Services Support Manager and is responsible for the overall information technical support systems of the Convention and several state entities that are housed within the Baptist Building. In cooperation with other SBC state conventions and national SBC entities, Information Services has been instrumental in developing an on-line database of all SBC congregations and leadership. This program is replacing or directly feeding data to all national database programs. The database consists of all information collected through the ACP each year, as well as information directly communicated to the office. All information is retained so as to maintain historical statistical and leadership information for each reporting congregation. Through her team's effort along with assistance from the entire State Mission Services Staff, ACP reporting of all Louisiana Baptist congregations maintains an above average reporting percentage within the SBC network of congregations. Also, congratulations to the 2015 Associational Clerks from 16 Associations who had 100% reporting for the 2015 ACP year.

The LBC Accounting Team, led by Rusty Johnson, provided Louisiana churches with on time and accurate information regarding the 2016 massive tax blitz by the federal government and the state of Louisiana. It started with the Affordable Care Act and filing the 1095C's. Then the Louisiana legislature, whom has the most complex sales tax laws in the U.S., required churches to collect sales taxes. Because you spoke up, the legislature reversed themselves and now the old rules apply after July 2016. In addition, consistent with prior years, the Louisiana Baptist Convention received an excellent review on their Annual Audit Report.

Tall Timbers' Director, Sam White, and his staff continue to serve the churches of the Louisiana Baptist Convention by providing a place for retreats, conferences, camps, seminars, and other events. This is accomplished by programs sponsored by Louisiana Baptist Convention entities, Tall Timbers, and church groups who provide their own programs. We again saw tremendous increases in attendance in our summer camps for youth and children in 2016. Many people are making life-changing decisions for God at Tall Timbers each year. This year, we continued construction of the Georgia Barnette Conference Center and hope to complete it in September 2016. The GBCC will be used to equip and inspire our churches to engage in mission activities that will make inroads into the lives of un-reached people of Louisiana. The chapel in the GBCC will be named "Kathryn Carpenter Chapel" and will replace the old chapel that was taken in the expansion of US Highway 165 in 2003. We also began conversion of the Cypress Conference Building back into a cabin and hope to complete that re-model in time for 2017 summer camps.

The Business and Information Services Team considers all of its various areas of support work as ministry unto the Lord. We count it a privilege to serve our Lord by serving our colleagues and Louisiana Baptists in the work of reaching Louisiana for Christ and strengthening our churches.

#### **BAPTIST COLLEGIATE MINISTRY**

### Mark Robinson, Director #Reach #Connect #Strengthen #Mobilize

Eight-nine thousand students **reached** by Baptist Collegiate Ministry. That's a number that is hard to understand. It is the equivalent of the 5<sup>th</sup> largest city in Louisiana behind metro New Orleans, Baton Rouge, Shreveport, and Lafayette. As this report is presented each fall, we are in the height of our student outreach. Every campus has purposeful outreach to touch the lives of collegiate with the Gospel of Christ that **Connects** the campus with the local church. The BCM ministry intentionally programs to **connect** college students with church staff and mission volunteers on the campus.

Over 4800 students can be considered active in our day to day ministry that includes discipleship, worship, fellowship and mission **mobilization**. The students are given opportunities to **strengthen** their walk with Christ and discover the unique plan God has for their lives.

Hundreds of students have been and will continue to be involved in Disaster relief to our state. The BCM staff and students are a key component of our states disaster relief strategy. Young, energetic missional strong bodies are among the first responders to go into homes and help remove flood damaged items and furnishings and haul out wet dry wall. I have witnessed and stood with students from all four corners of the state and in between bringing hope to families that have been devastated by the floods of 2016. We **mobilize** students to be the hands and feet of Christ.

One specific highlight is the hiring of Thomas Worsham, formerly First Baptist Minden Youth Minister, as the BCM director at Louisiana College. It doesn't take but a few minutes on campus to realize the impact BCM is having under his leadership. The future of Louisiana College is bright and BCM is right in the middle of all the great new things there.

We are currently in the midst of rain-soaked renovations at Southeastern Louisiana University BCM, but making great progress. Ground breaking for the new ULM BCM building will be held in September. Finally, please pray for college students as the work together to share the Gospel of Christ on campus for a 24 hour a day, and a weeklong event this October called Engage 24.

#### **COMMUNICATIONS TEAM**

And we have just added a giving page that talks about the basics and the blessings of tithing. Remember when your parents helped you put money in the envelope and you looked forward to putting that money in the offering plate? There's something exciting about giving back to God.

Externally, we desire to communicate God's truth to the two million or more people in Louisiana who do not have a personal relationship with Jesus.

Here for You, an evangelistic media campaign, was launched in mid-2014 to accomplish this desire.

*Here for You* has three primary goals:

- 1. Infiltrate and influence the culture.
- 2. Create opportunities for spiritual discussions.
- 3. Motivate those seeing the commercials to check out the Gospel and local Louisiana Baptist churches.

Following pilots in Southwest and Northeast Louisiana, we launched the third pilot of *Here for You* in 2015 in Southeast Louisiana. Through May of 2016, the TV commercials aired more than 11,275 times on broadcast and cable outlets in the New Orleans market. In excess of 3,700 people visited the splash page, LouisianaBaptists.info, resulting in an additional 2,600 views of the spots. There also have been over 200 searches for area churches and social media platforms such as Instagram, Pinterest and Twitter have generated hundreds of thousands of impressions and thousands of clicks.

#### **EVANGELISM-CHURCH GROWTH TEAM**

Wayne Jenkins, Director Keith Manuel, Evangelism Associate

The Evangelism/Church Growth Team seeks to assist Louisiana Baptists by serving as catalysts, consultants and conduits of ministry in areas of church programming. Wayne Jenkins serves as the Director for this team. He and Keith Manuel, Evangelism Associate, plan and coordinate the work of Evangelism with events such as the Evangelism Conference, which will be at Temple Baptist Church, Ruston, January 23-24, 2017, prison ministry, Bible distributions, and strategic planning and trainings for local associations and churches. In addition, this team facilitates the work of Revitalization, providing resources, tools, and consultations for churches to develop a customized strategy to address their needs. We provide both people resources and material resources to assist churches in reaching their commitments.

Steve Maltempi, Youth Ministry Strategist, coordinates work to reach, teach, and equip teenagers and their adult leaders. Our office conducted individual and associational Youth Ministry consultations and Youth Sunday School leadership training conferences. Clear Youth Camp held at Tall Timbers provided 3 different camp opportunities in July with record attendance of over 1,000 teenagers and leaders. Camp will extend to 4 weeks in 2017. The Youth Evangelism Celebration continues to be the largest ministry event in the Louisiana Baptist Convention with 5,700 attending at the Cajun dome in Lafayette in 2016.

David Anderson serves as the Children's Ministry Strategist. This year, Pre-Teen Invasion met at two locations, Temple Baptist in Ruston and at FBC, Lafayette. These events reached more than 1,200 children in grades 4-6. Vacation Bible School training was held at Tall Timbers and saw 400 being trained on the state level. Airline Baptist Church, Bossier City and the New Orleans Baptist Theological Seminary hosted the annual Childhood Education Workshop. Strong attendance continued with 560 weekday teachers receiving training and encouragement. Bible Drill also continues to hold strong interest with children across the state, committing God's Word to their memory weekly.

Jeff Ingram, Adult Ministry Strategist, coordinates the work of adult Sunday School, small groups, and discipleship. The Senior Adult Luncheon at the Evangelism Conference had over 785 attendees. The January Bible Study previews, the Baptist Doctrine Study previews were conducted. The Louisiana Baptist Christian Education Association continues to provide opportunities for ministers of education to find encouragement, develop strategies, and form networks. The two college student GOLA teams helped lead VBS in 24 churches this past summer. Sunday School, Small Group, and Discipleship training conferences for church staff and lay leaders continue to be requested.

Sean Keith, Sunday School/Discipleship Strategist, has partnered with churches and associations to offer 8 – 10 Associational Conferences and three Regional Conferences. Our statewide ReGroup Conference was at Summer Grove BC in Shreveport on August 13, 2016. We expect to train between 2000 to 2500 leaders in training events this year. In 2017, The ReGroup Conference will be in two locations on August 12, 2017 at FBC Covington and Philadelphia BC in Deville. We have launched the ReGroup Coaching and Cluster Coaching to assist churches who desire to revitalize their ministries. These resources, tools and events are found on <a href="https://www.louisianabaptists.org/regroup">www.louisianabaptists.org/regroup</a>. We continue to create online resources for print and video. Finally, churches have utilized the One Day Sunday School Evaluation, Pastor/Sunday School Director Workshops and other customized training events to help leaders develop key strategies for the future of their church.

#### MISSIONS AND MINISTRY TEAM

John D. Hebert, Director

The Missions and Ministry Team is comprised of Church Planting, Compassion Ministry, Mission Builders, Men's Ministry/Disaster Relief, and Women's Missions and Ministry under the leadership of John Hebert, Team Leader.

Dr. James Jenkins, Director of Church Planting, gives leadership to our church planting team. The team is engaged in carrying out one of the 2020 Commission goals through our 10-3-1 Associational Church Planting Strategy Plan. The goal is to plant 300 new churches by the year 2020, of which 100 will be new non-Anglo congregations. In order to impact lostness proportionately, the team worked to plant three churches in south Louisiana for every one new church plant in the north. Since 2010, the team has started over 150 churches over 50% of our goal. Dr. Jenkins is assisted by Carlos Schmidt and Lane Corley.

Led by a 20-member task force, **Women's Missions and Ministry**, is re-visioning the objectives and building strategic approaches in mission's education and women's ministry that will lead us to serve all people groups in today's generations and generations to come. As this develops we will better serve women, children and teens in our churches with fresh approaches through events and to equip leaders for ministry and missions that touch lives for Christ in all possible ways. Janie Wise and Jess Archer are committed to helping our churches pray for, give to, engage in and learn about God's work in our communities, our state, our nation and our world.

Dr. Jeffrey Cook leads our Compassion Ministries work and has continued to grow the Association Compassion Missionary (ACM) strategy in many of our urban associations. In addition, training activities continue all over the state to help churches know how to do compassion ministry. The goal is for EVERY church to participate in Compassion Ministry by 2020.

Dr. Gibbie McMillan, Disaster Relief and Men's Ministry Strategist reports there has been a great outpouring of volunteers to help the people whose houses were flooded throughout Louisiana. Hundreds of volunteers were trained in incident command and mud-out. We've had flooding regularly in our state for the past year and a half and the need for volunteers is growing. We have emphasized building strong relationships with the GOSHEP (Governor's Office of Homeland Security and Emergency Preparedness) AND THE EOC's (Emergency Operation Centers) across the state.

The Mission Builder program, under the leadership of Robert Woods, continues to help our missions and churches for first unit buildings and renovations. Significant progress has been made on the Georgia Barnette Conference Center and the work was completed in September 2016. Robert works with armies of volunteers from across the nation and state to help our missions and churches.

#### PASTORAL LEADERSHIP TEAM

Bill Robertson, Director

2015 was a very good year for the Pastoral Leadership Team. We were able to serve our churches in various areas of ministry.

The Shepherds Rest was conducted in 6 churches with 3 of them being bi-vocational pastors. It involved 40 Sundays filled by 18 volunteers to serve both the church and pastor at no cost to them.

Our team conducted 14 Pastor Search Committee training meetings around the state.

Conflict mediation kept us busy throughout 2015 involving 11 different churches and 17 different meetings.

The Church Administration area of our team conducted: 15 finance/budget meetings, 14 compensation planning meetings, 8 church documentation consultations, 12 administrative matters, 12 marriage/sexuality consultations, and 6 workshops for administrative assistants. There were 12 regional and associational GuideStone events and 152 individual appointments to help our pastors plan for retirement.

Through our partnership with Granberry Counseling Center, we were able to help 63 ministers and families.

#### LOUISIANA BAPTIST MESSAGE

During 2016, our 130th year of ministry in the Bayou State, the *Louisiana Baptist Message* continued to focus our coverage on the cooperative ministries that define Louisiana Baptists. We also began our second year to place an intentional emphasis on evangelism and soul-winning – to encourage an even greater harvest among our churches. Additionally, we responded to a number of emerging issues, events and developments which figured prominently in Louisiana Baptists collective work here, across the nation and around the world.

Early in the year we provided expansive reporting on the flooding across the state and Louisiana Baptists' extraordinary response to the tragedy through our comprehensive disaster relief efforts, including our work with Southern Baptists from 10 other states who joined us in the massive recovery effort.

More than 18,000 homes were affected, according to Federal Emergency Management Agency records.

Importantly, most of the destruction took place in the northern part of the state where 70 percent of our churches are located and a sizable portion of our disaster relief volunteers reside. Many of them were dealing with personal losses, but still contributed multiple weeks working to help others also in need. We told their stories of courage and commitment, sustained by their abiding faith in Christ.

We have only just begun to tell the stories of tragedy and triumph rising from the floods which hit the southern part of our state in August, destroying more than 40,000 homes.

But as in past disasters, our goal is to share such news in the context of God's prevailing grace and glory, and, especially His ability to take what might appear as evil and use it for good -- even for the transformation of someone's heart and life.

The *Louisiana Baptist Message* is not a crusading investigative journalism outlet -- our mainstay is not chasing down controversies. However, we are committed to transparency and to informing Louisiana Baptists so they can capably serve in their respective roles within the checks and balances that necessarily function at all three levels of autonomy within the Louisiana Baptist Convention and our Southern Baptist Convention affiliation.

In that regard, we asked direct questions Louisiana Baptists were asking -- and still want to know -- about decisions that have resulted in a radically reshaped overseas missionary force. We also addressed controversies being raised among Southern Baptists regarding an apparent schism among national leaders with respect to voting in the U.S. presidential election. The *Louisiana Baptist Message* also produced revealing articles about the three candidates in the vote for SBC president -- a critical leadership position during this time of obvious turmoil within our voluntary fellowship of churches.

But the overall focus of our ministry for 2016 is perhaps best represented by the headline of a special story package we published in the August 11 edition: "3,202 Saved in Brazil!"

Finally, we hope you are among the tens of thousands of readers who have noticed our revamped website. It allows us to provide more offerings for online readers while streamlining the process internally. We are able to better emphasize our Louisiana-specific content while also presenting something of a one-stop shop in our attempt to meet the many information needs of our readers.

Our pursuit of continuous improvement in the print edition and online version of the *Louisiana Baptist Message* is reflective of our commitment to address the wide span of information needs among the five generational cohorts that compose the membership of *Louisiana Baptists*' churches – the two generations who built a legacy of cooperative ministries in Louisiana, the generation presently stewarding these ministries and another just now making its mark, and the generations who will be following them.

Louisiana Baptists can rest assured the *Louisiana Baptist Message* remains a faithful partner in the Gospel.

#### **Section One**

#### **Program Development and Plans**

The Foundation was chartered as a non-profit agency of the Louisiana Baptist Convention in 1944 for the purpose of encouraging and assisting with gifts to the churches, institutions and entities of the LBC and the Southern Baptist Convention. A total of 14 Trustees govern the LBF with 12 elected by the Convention and the Executive Director of the LBC and the Convention President serving exofficio. The LBF receives approximately 31% of its operational funding from the Cooperative Program with the remainder provided through fee-based income on assets under management.

The Foundation continues to assist with gifts to support Baptist ministries and to provide investment management and trust administration services for churches, institutions and ministries of Louisiana Baptists, as well as for individuals who wish to sustain Baptist ministries into the future. Donors are encouraged and assisted with gifts through a variety of methods including Gift Annuities, Bequests, Donor Advised Funds, Charitable Remainder Trusts and Pass Through gifts. Some 2015 highlights included:

- ♦ Distributions of \$3,897,511 were made in 2015. The total market value of assets managed at December 31, 2015 was \$164,197,464.
- ♦ 411 Louisiana Baptist churches, agencies and institutions had over \$70 million on deposit in the Foundation's Short Term Fund (STF) at December 31, 2015. The STF provides a savings account option with instant liquidity and still offers a competitive interest rate. Other added benefits of using the STF include the ACH electronic transfer system and the monthly e-mail statement service. There were 310 participants in the ACH system in 2015.
- Gifts, bequests and trusts received by the Louisiana Baptist Foundation for the support of Christian ministry totaled \$6,132,277, in 2015. Every gift is significant because it supports ministries that spread the Good News of salvation through Jesus. Some examples are highlighted below:
  - "Pass-through" gifts exceeded \$4,000,000 for the year 2015. These are gifts of property such as securities or real estate, which are sold by the Foundation and the proceeds passed to the ministry chosen by the donor. The ministries receiving these gifts included several local churches, ministry in Alaska and Louisiana Baptist Children's Home.
  - Completed the successions and settlement of 3 estates that provided nearly \$600,000 to 2 local churches as well as international and North American missions.
  - Helped several families complete estate stewardship plans that will provide an estimated \$700,000 to the churches and ministries they have selected.
- In early 2016, the Foundation's advertising focus has been on a recent survey that revealed that 37% percent of regular tithers or givers to faith based organizations would leave a gift in their estate plans if they were asked! The Foundation staff is encouraging pastors and leaders of Baptist ministries to ask their supporters to remember their church or organization in their Will or estate plans to further the ministry of the Gospel.
- ♦ Cooperative Program dollars invested in the Louisiana Baptist Foundation yield great returns for the Convention and its entities. In 2015, the LBF received \$242,425 from the Cooperative Program and the LBF distributed \$3,232,338 to Baptist causes in return. Over the 71-year history of the Foundation, the Cooperative Program has invested \$9,388,099 while over \$121 million has been distributed for Baptist causes!

#### Louisiana Baptist Children's Home and Family Ministries

Dr. Perry Hancock, President & CEO

In its 117<sup>th</sup> year of ministry Louisiana Baptist Children's Home and Family Ministries continued its mission of providing love, care and hope in Christ for children and families in need. The Children's Home provided a positive Christian witness through its residential child and family care programs, foster care and adoption ministries, Granberry Counseling Centers, the Mobile Pregnancy Care Center, Christian Women's Job Corp, and Orphans Embrace.

In 2016 the Children's Home provided ministry services for over 4,400 children, families, and individuals. Through its residential and foster care ministries, LBCH served 205 children. Sixty-two of those children and their mothers were provided with housing and other support services through the HomePlace family care ministry.

Through its Connect 127 foster care and adoption ministries, the Children's Home provided support services for 90 children across the state. The mission of Connect 127 is to provide Baptist homes for Louisiana's foster children and to provide foster care and adoption ministry training for local churches.

The Granberry Counseling Centers staff provided professional Christian counseling for 1,552 individuals during the year. Through its Minister Care program, a partnership with the Pastoral Leadership division of LBC, Granberry provided counseling for 91 Louisiana Baptist minister families.

The Mobile Pregnancy Care Center provided a pro-life witness for over 1,200 women across the state. The Children's Home also maintained its support of a pregnancy resource consultant in partnership with the LBC Missions and Ministry division.

Christian Women's Job Corp provided life and job skills training for 91 women. New job skills certificate programs were added in 2016 and the high school equivalency track was updated. Classes were also provided for women at Robinson Place, a Monroe Housing Authority community.

In 2016 the Children's Home shared God's love in word and deed through its international orphan care ministry, Orphans Embrace. Eighty-three Louisiana Baptists ministered to over 1,100 children and others in Nicaragua, Guatemala, and Haiti. The Children's Home continued its partnership with Louisiana Baptists to provide care for orphans in Haiti.

Louisiana churches once again provided support for the Children's Home through the Annual Children's Home Sunday Offering. The offering provides for many of the critical needs the children have during the year. Churches also continued to support children and families at the Home through the Fall Food Roundup which provides all of the non-perishable foods needed for the entire year.

In the summer, churches from across Louisiana donated their VBS offerings to support the children. Many churches provided additional support in various ways throughout the year and God used LBC Cooperative Program giving from the churches to share His love with those in need.

As a result of the support from our churches and the great witness provided by the various ministries of the Home, over 180 people experienced the joy of salvation in Christ and received real hope for life and life eternal. Thank you Louisiana Baptists for meeting needs and changing lives through your Louisiana Baptist Children's Home and Family Ministries.

#### Dear Louisiana Baptist Family:

The Lord is at work at Louisiana College in so many ways that they are almost too numerous to note. By way of overview, we are grateful that our faith integration initiative was exemplified by 12 students who spent part of their summer in missions and ministry across Louisiana, the US, and the world, and by our Student Life personnel who led a mission team to serve at Acres of Hope in Uganda.

Perhaps most evident of God's favor at LC regards campus improvements. We are indebted to Campers on Mission, a team of retirees that refurbished our iconic fountain and completed several significant projects. Donor support fostered renovations in two residence halls that have received major work: carpet and paint in lobbies and corridors, bathroom fixtures, air-handling units, upgraded electrical power service, wireless internet access points, flat screens with Bluetooth technology, charging ports for mobile devices, and a movie room with theater seating. Resulting from a hail storm about a year ago, a significant insurance claim includes 18 campus roof replacements, numerous interior repairs, and the refurbishment of Guinn Auditorium's interior.

In an effort to further equip students for effective leadership and ministry, this fall we launched a BA in Leadership with concentrations in Christian Studies, Business, and Communications. Also, our new Bivocational Pastor Certificates -- one in Pastoral Ministry, the other in Missiology -- should ultimately enhance the ministry of many Louisiana Baptist churches.

Filling vital roles at LC, we promoted Dr. Jerry Pounds as Vice President for Academic Affairs, Dr. Cheryl Clark as Associate Vice President for Academic Affairs, CFO Randall Hargis as Executive Vice President, and Dr. Amy Craig as Dean of our School of Education. LC's head basketball coaches -- Patrece Carter, women; and Reni Mason, men -- were promoted to Associate Athletic Directors.

We also appointed Rev. Vincent Smith as Dean of Students. He will focus on student life, retention, service learning, and international student services. Rev. Smith will continue serving as the lead pastor for The Circle Church, a recent LBC church plant in Alexandria.

Thanks to a concentrated and maximized effort in recruiting, our enrollment indicators are very encouraging as they reveal a significant uptick in first-time freshman for the fall semester.

Our Board of Visitors continues to grow. To date, 96 people have committed to the BOV scholarship fund that wholly and solely aids qualified students, thus providing financial aid to more than 137 students. Such selfless generosity yields significant student assistance.

We want to invite all Louisiana Baptists to our first annual Values and Ethics conference, Oct. 10-11. This event will highlight the intersection of theology and science regarding humanity's origin, and how this worldview is shaping significant change in business, higher education, healthcare and other societal categories.

We are always grateful for our Louisiana Baptist Churches, whose members sacrificially support the Cooperative Program and enable the College to prepare graduates and transform lives. We offer our thanks today, and trust that eternal dividends will accrue as our graduates enter the marketplaces of the world and live out their Christian worldview daily.

Cathy and I are constantly reminded of God's blessings for us through Louisiana College, and we consider it a humble privilege to serve God and you as we minister for the sake of the College and the life-changing Gospel of Jesus Christ.
